3 Definitions

- 3.1 "Annual Fee" means the annual charge to the Member for the Membership Type as selected above.
- 3.2 The "effective date" is either the 1st January or 1st June which ever date is closest to the date of signature of the application.
- 3.3 "OpenNetworks" is OpenNetworks (Pty) Ltd a database management company appointed by the PVRA.

4 Duration

The Membership is effective from the date of signature and will continue until terminated by PVRA forthwith or by the Member on not less than one calendar month's written notice of termination to the PVRA or OpenNetworks.

5 Payment

- 5.1 The Member shall pay to the PVRA as from the effective date Annual Fees in advance, by debit order effected by OpenNetworks. Where the effective date is 1st June the member will be charged for half of that year.
- 5.2 Where the Member declines debit order as the method of payment, subject to approval by OpenNetworks, special payment arrangements, including EFT (Nedbank, 1972069926, Hyde Park 197205) or Cheque (Parkhurst Village Association), may be requested by the Member.

6 Confidentiality

PVRA will treat as "Confidential Information" any data owned by the Member and the PVRA undertakes:

- 6.1 to hold in confidence such Confidential Information disclosed to it by the Member;
- 6.2 to restrict its use of the Confidential Information to work performed in the provision of PVRA services;
- 6.3 to protect from public disclosure all Confidential Information in its possession. Such Confidential Information shall be kept secure and shall not be disclosed to any third party without the written consent of the Member.
- 6.4 to make copies of any documents or material received from the Member save as is necessary for the performance of PVRA services;
- 6.5 that the obligations hereto relating to the confidentiality and use of the Confidential Information shall survive the termination of the Membership.
